What are the key policies and initiatives guiding Namibia's renewables sector?

There have been five key policies and initiatives guiding the trajectory of Namibia's renewables sector. These are the White Paper on Energy Policy (1998), the Renewable Energy Feed-In Tariff (REFIT) Programme (2011), the National Renewable Energy Policy (2017) and the Namibia Green Hydrogen and Derivatives Strategy (2022).

Can renewables provide non-electricity energy in Namibia?

However, there is potential for renewables to scale up in providing non-electricity energy (primarily thermal energy for heating and cooking, if Namibia's ample bioenergy resource is utilized effectively, sustainably, and combusted in cleaner ways).

Why is electricity wheeling important in Namibia?

Government recognises the importance of electricity wheeling for the growth of Renewable Energy in Namibia in its further development of the electricity market framework.
