What happened to solar energy company in Texas?

The residential solar and storage provider filed for bankruptcy in the Southern District of Texas, reporting a range of \$10 billion to \$50 billion in both assets and liabilities, and total debt of \$10.67 billion. Financial documents also show that the company laid off 55% of its workforce.

Why are solar stocks falling?

Several solar stocks have suffered double-digit declines. Renewable energy companies were already struggling to navigate high interest rates and the higher cost of capital over the past year, and the recent draft legislation has only exacerbated the sector's financial strain.

Why did a solar business go bankrupt?

As difficulties worsened, businesses failed to fulfill their service and warranty obligations, ultimately leading to bankruptcy.
